## **(deprecated) (deprecated) Developing with the Case Participant Index**



Use this information to customize the case participant index. The case participant index supports central access to client information from multiple systems. Case participant index APIs can be used to store and retrieve client data. Client data can be loaded in the case participant index repository via a batch job or via a web service.

---

### **(deprecated) Introduction**

#### **(deprecated) Purpose**

The purpose of this guide is to provide instructions on how to utilize the Case Participant Index Component (CPI). It describes the entry points for both implementation and customization of the CPI and includes descriptions on using the CPI APIs and customizing the CPI data.

#### **(deprecated) Audience**

This guide is intended for developers and analysts responsible for customizing the Case Participant Index component to suit the business needs of an organization.

### **(deprecated) Using the Case Participant Index APIs**

#### **(deprecated) Introduction**

The Case Participant Index (CPI) supports central access to client information from multiple Systems of Reference (SOR). This chapter describes the CPI architecture and provides instructions on how to use the Case Participant Index APIs to store, and view client data.

#### **(deprecated) Case Participant Index Architecture**

There are a number of components that play a role in storing Cúram Case Participant Index (CPI) client data and making the client data viewable in components external to CPI.

**Note:**  Social Enterprise Folders (SEF) and Case Participant Index (CPI) are deprecated. For more information, see [Deprecated features](#)

These are detailed in the following sections.

There are two options for loading client data in the CPI repository. Either a batch job can parse the client data into the CPILoader by way of an interface or web services can deliver the data to CPI. Once the client data is loaded and stored in CPI, it can be accessed and viewed via the Social Enterprise Folder delivered by Social Enterprise Collaboration.

### **(deprecated) ClientAccessV1**

The ClientAccessV1 interface is integrated with the Social Enterprise Collaboration component. This allows for client data to be viewed in social enterprise folders and in the citizen context viewer.

### **(deprecated) CPIDataV1**

This is the container API that deals directly with the CPI repository. You can insert, read, and search data from CPI via this API.

### **(deprecated) CPIWebService**

This is the interface that allows access to via web service to the CPI. You can insert, read and search.

### **(deprecated) CPILoader**

This is the interface that loads data into the CPI via batch.

### **(deprecated) Storing Case Participant Index Data**

The Cúram Case Participant Index provides two interfaces for storing client data: the CPILoader and the CPIWebService. The CPILoader is designed to handle a bulk load of data, such as when a new CPI Data Store is initially populated. The CPIWebService interface has been engineered to allow an SOR to perform maintenance like updates, inserts and deletes in real time.

**Important:** For both interfaces, it is important to note that the unique keys returned for each entry must be mapped back to the SOR (and/or web service unique key mapping support tools) to ensure that the data can be properly maintained.

**(deprecated) Storing CPI Data by using the CPILoader:** The CPILoader interface is provided with CPI and can be used to store CPI data. It is a standard batch process as described in the [Cúram Batch Processing Guide](#).

The CPILoader structure requires two parameters to be specified: a log file name and a load file name. The log file name designates where the log output of the CPILoader run is placed. The load filename must point to an XML file based on the *CPIBatchLoader.xsd* XML schema. This schema essentially extends the schema used for performing web service calls to the CPIWebService. This allows for the reuse of code on the SOR when generating the CPI Batch Load input file.

The CPILoader was written to use the same Applications Programming Interface (API) as is used by the CPIWebService. The Batch Loader consists of a Java class, called CPILoader, which publishes a batch method called *loadData()*. CPILoader acts as a wrapper for the same Java code that is used by the CPIWebService. Using this approach ensures that data manipulation operations are performed in the same way by the Batch Loader as they are by the Web Service.

### (deprecated) CPILoader Structure

The CPILoader XML "input file" must contain a single, root element of type *CPIBatchLoad*. The *CPIBatchLoad* element can, in turn, contain one or more *CPILoadRecord* elements. Each *CPILoadRecord* consists of a single identifier element (which provides the unique ID and source system identifier for the record being inserted), as well as an *insertAttributes* element (which provides the details of the information to be inserted). The *insertAttributes* element is a complex XML type, and may contain child elements of type Person, Case, Relationship, or CaseMember, for example. The *insertAttributes* XML type is defined within the *CPIData.xsd* XML Schema File.

### (deprecated) Running the CPILoader

The best way to run the CPILoader is to start it from the command line of a computer where the application is installed and set up. You do this by running the build runbatch Ant target, and providing the command line parameters previously described. You must include the double quotation marks around the value of the -Dbatch.parameters property, exactly as you see it in the example. Do not include any white space within the double quotation marks

From a command prompt in the EJBServer directory of the installation, issue the following command on a single line:

```
C:\EJBServer> build runbatch-Dbatch.program=curam.cpi.external.batch.intf.  
CPIloader.loadData-Dbatch.parameters="loadFilename=<load-file-location>,logFilename=  
<log-file-location>"
```

Where:

- <load-file-location> is the actual path and file name of the XML file you want to load. Include the .xml extension. This is a required parameter.
- <log-file-location> is the actual path and file name where you want the CPI Batch Loader to generate the log file for this run. Note that the log file is overwritten, if it exists. This is also a required parameter.


After the command is issued, you can see the results of the run in the log file output in the log file name that you specified.

**(deprecated) Storing CPI Data by using the CPIWebService:** The CPIWebservice interface is provided with CPI and can be used to store CPI data. The CPI developer must write a client web service and call the *CPIWebservice.insert* method. This method parses the CPI data by using the CPIWebservice schema. It is necessary for the CPI developer to adhere to the schema in the development directory, for example *EJBServer\Components\CaseParticipantIndex\webervices*.

### (deprecated) Viewing and Using Case Participant Index Data

The ClientAccessV1 interface provides access to the client data stored in the Case Participant Index. More specifically, it allows this data to be viewed and used in the Social Enterprise Collaboration (SEC) components. Viewing CPI data outside of Social Enterprise Collaboration is not currently supported.

### (deprecated) Data in Social Enterprise Folders

**Note:**  Social Enterprise Folders (SEF) and Case Participant Index (CPI) are deprecated. For more information, see *Deprecated features*

Participants and their cases from Cúram Case Participant Index (CPI) data can be added to a Social Enterprise Folder (SEF) as clients and cases in order to aid Social Enterprise Collaboration. For more information on social enterprise folders, see the *Cúram Social Enterprise Collaboration* business guide.

### **(deprecated) Data in Citizen Context Viewer**

CPI Data can be viewed in the Family and Care and Protection components of the Citizen Context Viewer (CCV). This includes information about persons, their families, and their cases. For more information on the CCV, see the Cúram Citizen Context Viewer Guide.

### **(deprecated) Person Search and View Person Pages**

CPI Clients can be searched for via the Person Search page in the Social Enterprise Collaboration component where the component is operating with the *curam.clientaccess.external.enabled* property set to 'YES'.

### **(deprecated) View Case Page**

A default View Case page is provided which enables cases stored in the Case Participant Index to be viewed in the Social Enterprise Collaboration components. To access these cases, the *curam.clientaccess.external.enabled* property must be set to 'YES'.

---

## **(deprecated) Customizing CPI Data**

### **(deprecated) Introduction**

This chapter provides instructions on how to enable and disable CPI data and describes how to add additional data to the CPI data repository. CPISchema prerequisites must be met before customizing CPI data.

### **(deprecated) Enabling and Disabling CPI Data**

The Case Participant Index (CPI) component can be at its most rudimentary level be turned 'off' or 'on' when installed with the Social Enterprise Collaboration (SEC) component via the *curam.clientaccess.external.enabled* property. This is not a dynamic property; you cannot switch back and forth during application runtime.

### **(deprecated) CPISchema Prerequisites**

It is important to note before any customizations are made that while the CPISchema is flexible there are a number of data dependencies if using CPI with SEC. An example of the expected data for CPI is shown below in the appendix. Here is a run down of the required elements. Not supplying these elements and fields listed will destabilise the SEC component to a point where it is not supportable when the *curam.clientaccess.external.enabled* property is set to 'YES'.

## (deprecated) Adding Additional Data

### About this task

Here are the steps to add additional data to CPIData.

### Procedure

1. Add an entry in the CPI xml data of type 'AdditionalData'. Here is an example of how some additional data is stored on CPIData:

2. It is recommended that you add entries to the *BPOClientAccessAdditionalFields.xml* file located at <your-dev-directory>EJBServer\components\CaseParticipantIndex\message. By accessing these CPIData fields via the codetable descriptions in java, it will ensure that future DatastoreEntry attribute name changes won't break your java code.
3. Data gets loaded onto the DatastoreEntity table via the CPIWebservice or the CPILoader batch job. See *Chapter 2 Using Case Participant Index APIs* for more information.
4. To allow Social Enterprise Collaboration to read new CPI data, the ConcernRole table (and its related tables) should be updated to include any new CPI records that are added via the CPILoader or the CPIWebservice.

### **(deprecated) Introduction**
