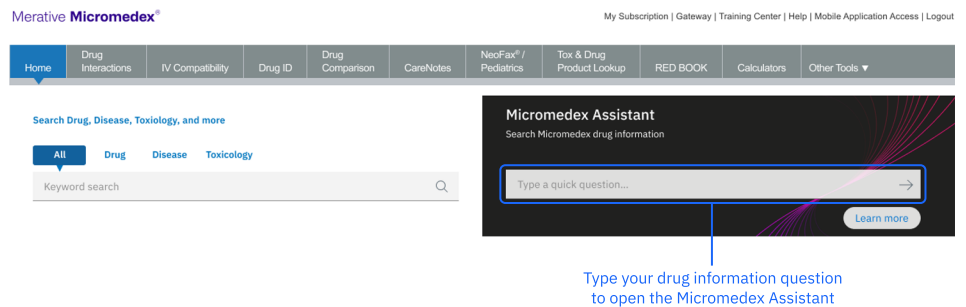


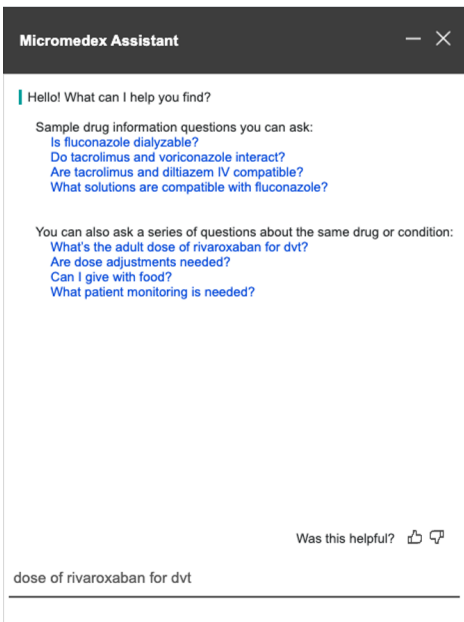

## Micromedex Assistant and Keyword Search

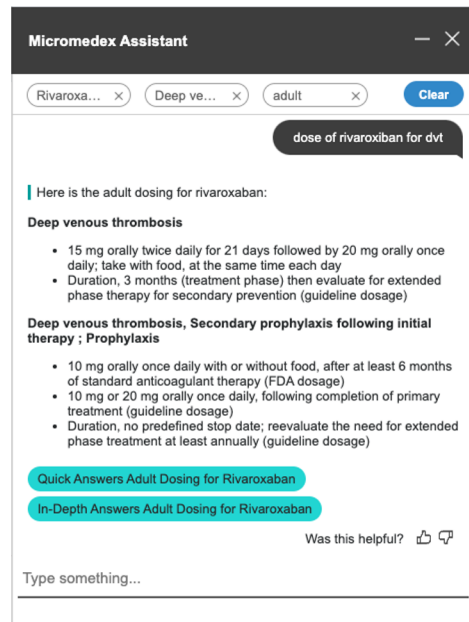

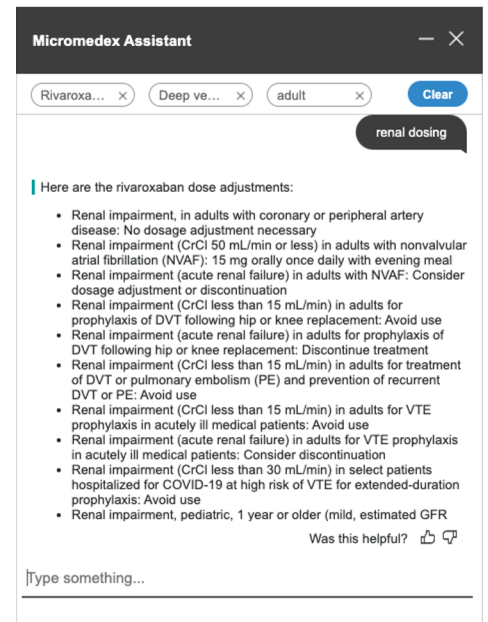
### 1. Ask a question

### 3. Get the answer

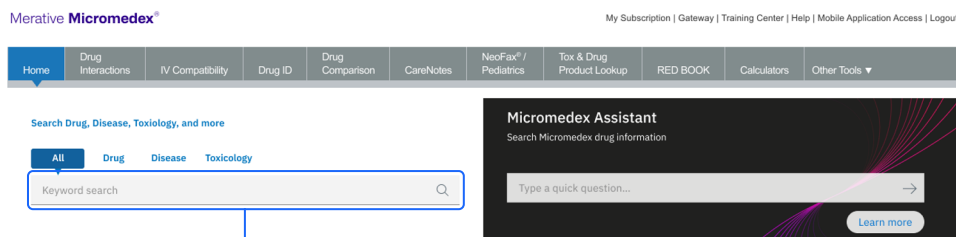


More sample questions the Micromedex Assistant can answer:

can i push ancef	monitoring for lasix	adrs for [drug]	bbw [drug]	monitoring for [drug]

## Micromedex with Keyword Search

Use the Keyword Search when you have general questions or want to read about a drug or condition.



Use the Keyword search for general, disease, or toxicology questions

Search Term/Phrase	Description
[YYYY]	Search by specific year (1995->). Returns the Drug Consult on drugs approved in that year. To see all: search on 'new drug approvals.'
Acronyms	Returns the Drug Consult, <i>Chemotherapy Acronyms and Dosing</i> with Alphabetical list of Chemotherapy acronyms and dosing regimens. Can also search specific regimens
ABVD	Returns drug consult, <i>ABVD – Used for Hodgkin’s Disease Chemotherapy regimen.</i>
Clinical approach to	Returns links to toxin-induced disease states (e.g., Hyperthermia, Hypotension).
Chemotherapy	Returns Drug Consults such as <i>Chemotherapy Dosing in Obese Patients, Chemotherapy and radiotherapy Treatment Guidelines for Nausea and Vomiting</i> and others.
Drugs that treat aspergillosis	Returns drugs that treat aspergillosis based on Efficacy Rating. Try 'drugs that treat' for other indications.
Drugs that cause Hyperkalemia	Returns a list of drugs associated with hyperkalemia. Click on 'T' & choose tacrolimus; see tacrolimus adverse effects. Under Serious, Endocrine: view incidence for hyperkalemia. For more detailed evidence on this ADR, click <b>In-Depth Answers, Endocrine/Metabolic, Hyperkalemia.</b>
Guidelines	Returns an extensive list of Drug Consults summarizing treatment guidelines covering infectious diseases, cardiovascular, neurologic, immunologic, endocrine/metabolic, and more.
Drug interactions* (include * as wild card)	Returns list of individual Drug Consults reviewing specific inhibitors, inducers, and substrates.
Opioid	Returns list of drugs in the opioid class.
Opioid* (include * as wild card)	Filter All Results by Drug. Returns Drug Consults focused on treatment of pain, opioid-induced constipation, opioid withdrawal, and others.
Extravasation	Returns results that include Drug Consults, <i>Cytotoxic Drug Extravasation Therapy and Non-Cytotoxic Drug Extravasation Therapy.</i>
Beers	Returns Drug Consult, <i>Beers Criteria–A Summary of Potentially Inappropriate Medication Use Among the Elderly.</i> Try searching stopp to access START/STOP Drug Consult.
AHA	Filter All Results by Drug. Returns Drug Consults covering a variety of guidelines from the AHA. Try 'CDC', 'IDSA', 'ACCP', 'ACR'.
